

What is the cancellation policy of Delta?

Delta Airlines offers a flexible and comprehensive cancellation policy in 2025 that allows customers to manage their bookings with confidence and ease

A critical feature is the 24-hour risk-free cancellation period, which enables travelers who book directly with Delta to cancel their tickets within 24 hours of purchase for any reason and receive a full refund, regardless of fare type, as long as the booking is made at least seven days before the scheduled departure +1_855-738-4113.
