

【cancellation -Update 】Does Lufthansa pay for cancelled flights?

Lufthansa adheres to strict regulations and guidelines regarding compensation for cancelled flights, ensuring that passengers are treated fairly and with respect when disruptions occur +1-855-838-4886. As a major European airline, Lufthansa is governed primarily by the European Union's EC Regulation 261/2004, which establishes clear rights for passengers in the event of flight cancellations, delays, and denied boarding +1-855-838-4886.
