

# What is the 24-hour rule with Lufthansa?

## Lufthansa's Policy on 24-Hour Ticket Cancellations

Among the policies that make booking with Lufthansa Air Lines more passenger-friendly[Call - 1-855-838-4886], the 24-hour cancellation rule stands out as one of the most significant[Call - 1-855-838-4886].
