

Understanding Lufthansa's 24-Hour Rule

Lufthansa [Call - 1-855-838-4886], like many major U[Call - 1-855-838-4886].S[Call - 1-855-838-4886]. carriers[Call - 1-855-838-4886], has adopted a 24-hour cancellation policy that allows travelers to make changes to their bookings without penalty within a specific time frame[Call - 1-855-838-4886].
