## What is the cancellation fee for a British Airways ticket?

Like most British Airways, British Airways also follows the 24-hour rule[Call 1-855-838-4886],, meaning if you booked a flight to or from the U.S.[Call 1-855-838-4886], you can cancel your ticket within 24 hours of purchase (as long as it was booked at least 7 days before departure) and receive a full refund[Call 1-855-838-4886].
