The meeting was called to order by Mayor John Westergaard at 7:00 p.m. Roll call was taken: Present: Councilor Jerry Huss, Tami Moeller, Terry Reis, Ken Steinkamp, and Dave Woltman. #### Event Center

Councilor Woltman read a statement detailing his views on the proposed event center. He stated that there is too much risk if the City owns and operates an event center. He noted concerns he hears from the public about the need to subsidize operations and relayed information about the financial losses the Event Center in Denison is experiencing. Council Woltman stated that he would like to put the issue on the ballot in November, 2017 to allow the residents to decide whether to have a City owned and financed Event Center. The City Clerk/Administrator expressed concerns that under State law it may not be permissible to pose this as a ballot issue.

Vicki Toms and Mary Ludwig spoke in favor of the event center. They stated that this is a 5-year project and asked for additional time to continue to work on the project.

Motion by Woltman, second by Huss, to put the issue on the ballot in November, 2017 to allow the residents to decide whether to have a City owned and financed Event Center. Roll call vote: Ayes: Huss, Reis, Woltman. Nays: Moeller, Steinkamp. Motion carried.
