Aquatic Vegetation Harvester: The City Clerk/Administrator reviewed the operating costs for the vegetation harvester and the revenues forthcoming from partners to help pay these costs.

Library Construction Project: The City Clerk/Administrator reported that the Library Board met with a representative from the State of Iowa NW Regional Library to discuss the planning process for a building expansion. She suggested that the Board use the services of a Library Consultant. The State Library has a grant to help pay for these services. The Library Board will be applying for this grant.
