Discussion – Equipment Sale

Interim Administrator Gibson presented a list of equipment to potentially sell, a snow bucket and dig bucket for a backhoe the City no longer owns, the old Fire Bus and an Old Fire Truck. After some discussion, City staff will look into selling some items and possibly modifying other items to make them usable again.

<u>Discussion – Dump Concrete Pile and Dump Log Disposal</u>

The Council discussed no longer allowing concrete to be taken to the City Brush Site, an arrangement has been made with Chewy Mohr to confirm he would accept it at the Mesiter Pit. City Staff will look at ways to educate the public on the new procedures.

Discussion was also held regarding adding some smaller logs to the brush site every time it is burned to start eliminating the large accumulation of logs.

Discussion – EVAPCO Incentives Request

Brett Meyer, representing EVAPCO, gave a list of items they would like to see for incentives from the City regarding their new building project. They are requesting a tax abatement, a rebate on the cost of the transformer needed for the new building and for the City to pay for a dedicated electric line to EVAPCO.

<u>Discussion - Planned Unit Development Zoning Document</u>

Interim Administrator Gibson reviewed the intent and purpose of implementing a Planned Unit Development Zoning Ordinance.
