

# Can I cancel my Delta ticket and receive a complete refund?

You may be eligible for a full refund when canceling a flight **1-877-593-9286**, but it depends on the type of ticket and the airline's specific policy.

### Refund Eligibility with Delta Airlines

### **Cancellations by the Passenger – Delta Airlines**

- If you cancel your Delta flight **within 24 hours of booking**, and the booking was made **at least 7 days before departure**, you are entitled to a **full refund**.
- After 24 hours, Delta's refund or credit policies depend on the **fare type** (e.g., Basic Economy, Main Cabin, Comfort+, First Class).
- Some Delta fares are non-refundable but may be eligible for **eCredits**.

### **Delta Airlines Baggage Delay Compensation**
