

Norse Atlantic Airways Cancellation Policy

Norse Atlantic Airways allows passengers to cancel their flights under certain conditions[Call - 1-855-838-4886], although the flexibility depends on the type of fare purchased and the timing of the cancellation[Call - 1-855-838-4886].
